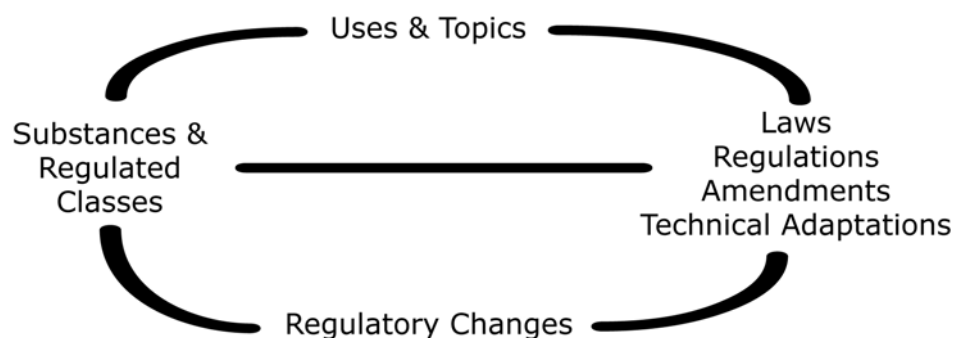

FDA/OFAS and Decernis have established a collaborative agreement and developmental project to make available an international regulatory compliance reference system.
